A Court of Thorns and Roses

Genre: Young Adult/Fantasy

Summary: When nineteen-year-old huntress Feyre kills a wolf in the woods, a beast-like creature arrives to demand retribution for it. Dragged to a treacherous magical land she only knows about from legends, Feyre discovers that her captor is not an animal, but Tamlin—one of the lethal, immortal faeries who once ruled

As she dwells on his estate, her feelings for Tamlin transform from icy hostility into a fiery passion that burns through every lie and warning she's been told about the

beautiful, dangerous world of the Fae. But an ancient, wicked shadow grows over the faerie lands, and Feyre must find a way to stop it . . . or doom Tamlin—and his world—forever.

My Review: This book started off amazing. A young girl, forced to teach herself to hunt in order to keep her family from starving and doing so day after day all alone in dangerous, wolf-infested woods...it sort of had a *Hunger Games* feel to it. An exciting plus was the threatening fae, who used to enslave the human race but now live behind their own wall in order to separate the two races, although they were known to sneak out and prey on humans for entertainment from time to time. Interesting, right? But after the initial action the first several chapters bring, the story kind of slowed down. Sarah J. Mass is so good at action and I craved more.

I read later that this was supposed to be a retelling of Beauty and the Beast. I really did not get that vibe in any way, shape or form. When I read Cinder by Marissa Meyer I kept thinking to myself, This book reminds me of Cinderella...and then, lo and behold, it was a retelling! But when I read that about this book I was just like...I'm sorry, what? You gotta be kidding me. Because isn't the whole point of Beauty and the Beast based on the Beast looking...well, beastly? Which makes it highly unlikely for Beauty to fall in love with him? Because, while Tamlin can change into a wolf, in his human form Feyre makes it clear that he is painfully beautiful. What? You're telling me a 19-year-old girl fell in love with a beautiful, rich, pained and completely non-evil Faerie? Shocking.

A lot of reviewers go on and on about Tamlin and how much they love him and need him and yada yada, and, don't get me wrong, I liked him too, but honestly I didn't feel as though I really knew him all that well. I felt like I knew Lucien better, which shouldn't be the case. So their love just didn't seem that believable to me and I didn't really feel the chemistry the way I like to. It was like it went from icy hatred to passionate love in the space of a few chapters and left me questioning whether or not I had zoned out while listening and missed something crucial.

BUT I still really enjoyed this book. The plot was magical. It took twists and turns that I never saw coming and the ending of the book, blessedly, did not leave a cliffhanger. I am actually really interested to read the next book, which is a rarity for me lately. Really, had I realized ahead of time that this book had just come out in May I probably wouldn't have read it yet at all. Wanting to read a book that isn't out yet will one day be the cause of my demise. And the second one won't be out for a whole other year. At least. Kill me now.

Parental Guidance: 14-17 years (BN.com). I'm going to straight up disagree with Barnes & Noble on this one and say 16 and up. There is one pretty hot and heavy scene in which some details are described intimately, as well as a few other less intimate scenes that I still wouldn't necessarily want my 14-year-old reading. There was also a bit of gory violence as well of retellings of violence in the past. The profanity was minimal, if any.

Stand Alone or Series: A Court of Thorns and Roses is the first book in the series. There are two more scheduled to be released in 2016 and 2017 but have yet to be titled.



The Gospel Focus of Charles Spurgeon

by Steven J. Lawson

The Gospel Focus of Charles Spurgeon by Dr. Steven Lawson offers an excellent insight into the preaching of Charles Spurgeon, the British Particular Baptist preacher from the late 19th century who is widely regarded by many, especially Reformed Christians, as the "Prince of Preachers." This book by Dr. Stephen Lawson focuses briefly on Spurgeon's biographical background but actually focuses the bulk of attention to addressing the strongly evangelical approach that defined Spurgeon's teaching and preaching. Spurgeon had a love of the Scriptures and




believed strongly in the plenary, verbal inspiration of the Bible. One of the first passages that Spurgeon preached upon, that in many ways defined his life and ministry, was the passage from Acts 5:42: "And every day, in the temple and from house to house, they did not cease teaching and preaching that the Christ is Jesus."

Spurgeon was also strongly Calvinistic in his preaching, believing that Scripture clearly taught the doctrines of God's election and sovereignty, yet at the same time his ministry was strongly one of evangelical Calvinism, with conversion of the unsaved being fundamental. There was no cold "hyper-Calvinism" with Spurgeon, but rather a gospel-centered message in which he would plead with the sinner to repent and to trust in Christ for forgiveness. To Spurgeon preaching that did not lead to conversion was pointless.

One thing noteworthy about learning about Spurgeon's life and his particular time frame in the late 19th century is how it wasn't that much different from our own age, with so much of the church turning into a ridiculous carnal stage, with the age of autonomy of man ruling over that of God's sovereignty. Much like today, Calvinism had been steadily decreasing since the 16th century and liberalism had brought many negative changes to the church of Spurgeon's age. But with Spurgeon, his strongly Calvinistic, evangelistic voice served as a mighty instrument of preaching God's inspired word and his life and works are of great value to be studied.


Jack Leo Welch



Pioneer Woman's Chicken with **Tomato & Garlic**

Ingredients

- 8 pieces Chicken Legs Or Thighs (on sale \$0.99lb!)
- Salt And Pepper, to taste
- 3 Tablespoons Olive Oil • 1 Tablespoon Butter
- 1 can (28 Ounce) Diced Tomatoes
- 1 can (14 Oz. Size) Whole Tomatoes
- 2 Tablespoons (Heaping) Tomato Paste
- Fresh or Dried Herbs: Basil, Parsley, Sage, Rosemary • 8 cloves Garlic
- 16 ounces, weight Pasta (I Used Cavitappi)
- Grated Parmesan Cheese, For Serving • 1/2 cup White Wine (or Red Wine)

- Preheat oven to 400 degrees. Salt and pepper chicken legs.
- Pour in wine, scraping the bottom of the pan to loosen any bits. Cook for 1 minute. Pour in tomatoes with their juice and add tomato paste. Add salt and pepper to taste, stirring to combine. Bring sauce to a boil, then turn off heat. Add plenty of fresh herbs, 8 cloves of peeled (but whole) garlic, and the chicken legs. Put lid on pot and cook in the oven for 1 hour.
- Remove pot from oven and allow it to sit on the counter with the lid on while you boil the pasta.
- Cook the pasta to al dente, Drain and add to a large serving bowl.
- Remove lid and check sauce. If it's overly thin, remove the chicken from the pot and boil the sauce on the stovetop for 5 to 10 minutes. Check seasonings and adjust as needed.
- To serve, pour sauce over cooked pasta, then arrange chicken pieces over the top. Sprinkle generously with fresh Parmesan and serve with crusty French bread.

Dry Drowning: What Every Parent Needs to Know Written by Kathleen Berchelmann, M.D.



It's not often that I beg parents to bring their kids into the ER, but that's exactly what I did when I heard about a child with a dry-drowning episode. He knew how to swim but he inhaled some pool water by accident. He coughed a bit, but a few minutes later was back in the pool. The child looked fine, the parents reassured me. It was bedtime, and everyone was tired after a long day in the sun at the pool. "We'll let him sleep, and if he's having any issues in the morning we'll take him into his pediatrician," the father told me.

"No, you need to come to the ER now," I told him. He didn't want to believe me. They reluctantly came, forking over Floating Lifebealttheir \$250 ER co-pay with annoyance. Then I showed them his chest x-ray that revealed extra fluid in his lungs, and his laboratory results including a low sodium level. The atmosphere in the exam room changed from annoyance to fear. This was real. Their child was drowning.

Dry drowning scares me. The kids can look fine- they just had a little sputtering and coughing episode after a scary moment while swimming. Occasionally dry drowning can happen in the bathtub. But sometime within the next 24 hours their lungs start a massive inflammatory reaction to the water they inhaled into their lungs. Sometimes they need a ventilator to breathe for them, and drugs to keep their blood pressure up. But the worst cases of dry drowning are the children I never see, the ones who were put to bed and never wake up in the morning.

My patient was ultimately fine- he was admitted to the hospital overnight and treated with oxygen and IV fluids, but by the next day he was well. He was a lucky one.

There is some debate about the definition of the term "dry drowning"usually this term refers to situations where some water got in a child's lungs and the child has a severe inflammatory reaction to the water hours after the incident. This phenomenon is also called "secondary drowning," or "near drowning." There is another phenomenon, also sometimes called "dry drowning," in which suffocation occurs but no water ever entered the lungs. In these rare situations, the larynx (voice box) spasms and stays shut, causing involuntary suffocation. Sometimes this spasm is triggered by water droplets hitting the larynx, or a sudden high speed submersion under water such as off a high-dive or a high speed water slide. This latter form of dry drowning generally doesn't occur when kids are simply swimming or playing in the pool. These patients are also immediately ill. They may never come up from the water.

What are the warning signs and symptoms of "dry" or delayed drowning? When do parents have to worry about a child who had trouble while swimming? These are reasons to bring your child to the Emergency Room, even if they look fine:

Coughing: Any person who has persistent coughing after playing in the water is at risk for water in their lungs. You may be thinking, "but this happened to me a million times when I was a kid." But what was your oxygen level while you were sleeping that night? You may have dropped and no one ever knew. Don't go to bed worrying, just take your child in for evaluation.

Water rescue: Any person who was submerged in water and came up struggling, especially if he or she had to be retrieved from the water by a lifeguard, parent, or other bystander needs medical evaluation. This may seem obvious, but I've seen kids get back in the pool and play after a water rescue.

Amnesia: Any person who was unconscious underwater or has limited memory of an incident that occurred in water needs immediate medical care. I had a patient once who had an underwater head injury with loss of consciousness, but finished her swim meet before going to the ER. I'm just thankful she didn't drown or bleed into her brain during that second race.

Behavior change: If your child feels sick, acts too sleepy, or has a change in mental status/behavior after a day at the pool, take it seriously. The worst thing you can do with a child who may have inhaled water is put them to bed. They need immediate medical care.

Vomiting: Vomiting after a day of swimming can be due to waterborne infectious disease (poop in the pool water...), but can also be a sign of severe illness due to dry drowning.

Ultimately, the best way to prevent drowning is to teach kids how to swim. The best time for swim lessons is about age four. Children under age four may benefit from lessons to get acclimated to the water, but don't count on lessons to keep your toddler safe in the water. Instead, read these 5 tips for safe water fun, quit worrying, and enjoy your day at
